### Criteria for show:

- Art presented must be your own original work of high quality.
- We will consider mastery of craftsmanship, technique, design, creativity, originality of concept or process, and evidence of artistic practice.
- All art on canvas, paper or other media must be ready to hang with appropriate hardware (wire one-third from top of art piece). Art on paper must be framed. There will be pedestals for 3D artwork display.
- Liberty Arts Guild reserves the right to reject any work deemed unsuitable.
- LAG will take great care in handling your artwork; however, we are not responsible for damage, loss due to theft, of any art on display. Artists should consider their own insurance coverage for these eventualities.
- All work must be picked up at the end of the show or by an agreed-upon time. A \$5.00 fee per piece will be assigned for unretrieved work unless provisions are made otherwise.
- LAG will provide labels with your name, title of art piece, medium used, and price.
- LAG will provide refreshments for shows and gallery openings. The reception for this show will be on March 15, 6:00 to 8:00pm.
- There is a limit of **six** pieces of art per person submitted for this show, exceptions for sets.
